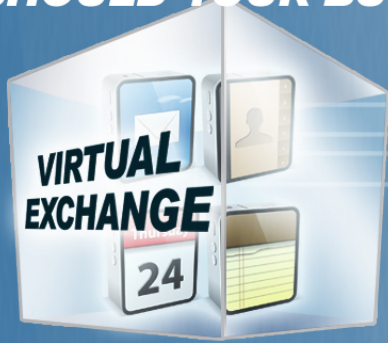


SHOULD YOUR BUSINESS MOVE TO VIRTUAL EXCHANGE?



NOT YET, IF:

- YOU WORK IN A **SINGLE** LOCATION
- YOU **HAVE** ON-STAFF EXPERTISE (INTERNAL IT SUPPORT)
- YOU OWN **NEW** (OR RELATIVELY NEW) HARDWARE
- YOU OWN **NEW** (OR RELATIVELY NEW) SOFTWARE
- YOUR EMPLOYEES **DO NOT** NEED TO ACCESS EMAIL REMOTELY (ALL WORK ON-SITE)
- YOUR EMPLOYEES **DO NOT** NEED ACCESS TO EMAIL VIA SMARTPHONE/TABLET PC
- YOU HAVE **CONSISTENT** POWER/INFRASTRUCTURE
- YOU HAVE **NO** PHYSICAL SECURITY ISSUES
(i.e. CONCERNS OVER THEFT OR VANDALISM)
- YOU HAVE **NO** DATA SECURITY CONCERNS
(i.e. NO REGULATORY OR INTELLECTUAL PROPERTY CONCERNS)
- YOU ARE RUNNING A **SINGLE** SMALL BUSINESS SERVER (SBS)

CONSIDER IT...

- YOU WORK IN **MULTIPLE** LOCATIONS
- YOU HAVE **NO** ON-STAFF EXPERTISE (INTERNAL IT SUPPORT)
- YOU OWN **OLDER** HARDWARE
- YOU OWN **OLDER** SOFTWARE
- YOUR EMPLOYEES **REQUIRE** SECURE **REMOTE** ACCESS TO EMAIL
- YOUR EMPLOYEES **NEED** ACCESS TO EMAIL VIA SMARTPHONE/TABLET PC
- YOU HAVE **CONSISTENT** AVAILABILITY (CONNECTIVITY)
- YOU HAVE **PHYSICAL** SECURITY ISSUES
(i.e. CONCERNS OVER THEFT OR VANDALISM)
- YOU HAVE **DATA** SECURITY CONCERNS
(i.e. REGULATORY OR INTELLECTUAL PROPERTY CONCERNS)
- YOU HAVE **MULTIPLE** SINGLE TASK APPLICATION SERVERS
